

**SUMMARY ANNUAL REPORT (SAR)

This is a summary of the annual report of the BWC TERMINAL HOLDINGS LLC EMPLOYEE BENEFIT PLAN, EIN 46-1645045, Plan No. 502, for period 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BWC TERMINAL HOLDINGS LLC has committed itself to pay certain self-insured Dental claims incurred under the terms of the plan.

**Insurance Information**

The plan has contracts with VISION SERVICE PLAN, DEARBORN LIFE INSURANCE COMPANY, and BLUECROSS BLUESHIELD OF TEXAS to pay Medical, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$5,401,127.
